## 1.0 EVENT SUMMARY

1.1 The Geelong Revival Motoring Festival (the Event) is conducted under the FIA International Sporting Code including Appendices, the National Competition Rules and the Sprint – Lap Dash Standing Regulations of Motorsport Australia, the Motorsport Australia Motor Sport Passenger Ride Activity Policy, these Event Supplementary Regulations, Further Supplementary Regulations and any Bulletins or Instructions to competitors that may be issued.

1.2 The Geelong Revival Motoring Festival, here in after is referred to as ‘the event’.

1.2.1 The event will be a **National Classic Sprint Event**, and open to all members of Motorsport Australia affiliated car clubs, who hold the appropriate Motorsport Australia “Speed” Competition Licence or higher.

1.2.2 The event will be a 400m sprint and will be held on a closed road section of Ritchie Boulevard and part of Eastern Beach Rd. The surface is bitumen. All runs will be in a single direction.

1.2.3 The Motorsport Australia Permit Number authorizing the event is **823/2611/03**

1.3 Sponsor/Official Rides:

During breaks between competitive activities EVENT SPONSOR and EVENT OFFICIAL Passenger Ride Activities may take place.

1.3.1 Each ride will be conducted in accordance with the Motorsport Australia Motor Sport Passenger Ride Activity (MSPRA) Policy.

1.3.2 Participation in these activities will be by invitation only from the Event Organisers.

4.4 Officials Dress Code

A dress code applies to all race officials including flag marshals, holding bay marshals and pit marshals (not applicable to emergency response staff).

The dress code is neat plain white shirts, t-shirts or tops (no logos). Pants, shorts or skirts are not defined.

There will be limited caps, vests and lightweight coats available from the Event Secretary if required.

In the case of poor weather, any appropriate wet weather equipment is acceptable regardless of colour.

## 5.0 JUDGES OF FACT

5.1 Protests if any, will be accepted only if made in accordance with the NCR.

5.2 In accordance with the NCR the following officials are deemed to be Judges of Fact.

- 5.2.1 Clerk Of Course
- 5.2.2 Event Secretary
- 5.2.3 Timing Officials
- 5.2.4 Start Line Officials
- 5.2.5 Flag Marshals
- 5.2.6 Holding Bay Officials

5.3 Officials of the event are deemed to be Judges of Fact of the following:

- 5.3.1 Not wearing seatbelt, helmet or safety clothing
- 5.3.2 Service Park infringements
- 5.3.3 Hitting or by-passing Chicanes
- 5.3.4 Other incidents as required

5.4 Scrutineers are deemed to be Judges of Fact of the following:

- 5.4.1 Oil leaking from vehicles
- 5.4.2 Vehicle with accident damage
- 5.4.3 Weight of a vehicle
- 5.4.4 Eligibility of Vehicles
- 5.4.5 Driver Apparel

5.5 Medical Officers are deemed to be Judges of Fact of the Medical condition of:

- 5.5.1 Any competitor, crew member or team member.

5.6 Speed Monitoring Officials using suitable equipment are deemed to be Judges of Fact regarding the speed of a competing vehicle or service vehicle.



## 6.0 COMPETITORS ELIGIBILITY

### 6.1 Competition entries

All competition entries must be lodged via the Motorsport Australia Member Portal at

[www.motorsport.org.au](http://www.motorsport.org.au)

If you do not have access to the Motorsport Australia portal, please contact the Secretary of the Event Chris Sager for assistance – [chris@geelongrevival.com.au](mailto:chris@geelongrevival.com.au) or 0431 183 176.

Entries may be refused in accordance with the NCR.

### 6.2 Motorsport Australia Competition Licence

The driver must hold, as a minimum, a current Motorsport Australia Speed, Speed Junior Licence. Minimum age for drivers is 16.

No Single-Event Licences will be available, as per Motorsport Australia guidelines.

### 6.3 Clothing & Apparel

All apparel must be in accordance with Article 1.4 (National) of Technical Appendix - Schedule D of the Motorsport Australia Manual.

This includes the following:

- 6.3.1 Safety helmets shall be in accordance with Article 1.4 of Schedule D.  
Open-face helmets are permitted in vehicles with enclosed cabins.  
Full-face helmets are required for open-cabin vehicles.
- 6.3.2 Clothing of a non-flammable material must extend from neck to wrist and ankle.  
Driving suits are NOT required.
- 6.3.3 Gloves are mandatory for vehicles with open cabins.  
Gloves are encouraged in vehicles with enclosed cabins.
- 6.3.4 Shoes with leather uppers that cover the foot or of a better standard (e.g. racing shoes to FIA8856-2000 standard) must be worn.
- 6.3.5 All open Sports and Racing Car drivers must wear goggles or a visor with plastic lenses complying with AS1609/1981.  
Glass lenses, whether laminated or not, are not permitted.

## 7 VEHICLE ELIGIBILITY

### 7.0 Suitability

The Organiser will have complete discretion in deciding the suitability of participating vehicles and may reject the entry of any vehicle deemed unsuitable, inappropriate, or ineligible.

### 7.1 Fire Extinguishers

Each competition vehicle must be equipped with a fire extinguisher which complies with Technical Appendix - Schedule H of the Motorsport Australia Manual, except where noted in specific Group/category/class regulations. The extinguisher must be mounted within reach of the driver, using metal bolts (not tech-screws or zip-ties).

## 7.2 Compliance

Vehicles must comply with Technical Appendix - Schedules A and B of the Motorsport Australia Manual, and/or the requirements specified in Motorsport Australia Manual Classification of Automobiles, 5<sup>th</sup> Category - Historic Cars where applicable. All vehicles entered in a historic group must comply with the applicable 5<sup>th</sup> Category regulations.

### 7.2.1 Battery location

Vehicles must display a Motorsport Australia approved blue triangle (minimum edge length 150mm) to indicate the location of the battery – refer Technical Appendix –Schedule B Article.

## 7.3 Competition Numbers

Competition Numbers are to be fixed to both sides of the vehicle, on side glass where possible. All vehicles must carry competition numbers in accordance with the requirements of the Technical Appendix - Schedule K of the Motorsport Australia Manual. Where possible, previously held competition numbers will be allocated. All numbers can be single, double or triple digit.

## 7.4 Noise

All vehicles must comply with the sound emission requirements of Technical Appendix -Schedule B of the Motorsport Australia Manual, i.e. not exceed 95dB(A) at 30metres from the edge of the track.

## 7.5 Electric Vehicles

As per the Motorsport Australia Electric Vehicle Standing Regulations, only series production vehicles will be permitted to compete in the sprints. Home-built EVs will not be permitted under the current safety plan.

### **An EV may be:**

- Hybrid EV: the electric motor provides tractive force to move the Automobile in conjunction with or independent of an internal combustion (IC) engine. The IC engine, in conjunction with a generator, provides the charging for the battery pack.
- Plug-In Hybrid EV: the battery pack is rechargeable by being plugged into an external power source. The tractive force to move the Automobile may then be provided by the electric motor or supplemented by an IC engine, which may also provide charging through a generator.
- Battery EV: the battery pack is rechargeable by being plugged into an external power source. The tractive force to move the Automobile is provided only by an electric motor.

## **RECHARGING**

### **No recharging is permitted within the pits.**

There are EV charging points on Brougham Street, outside the sprint holding bay.

Any EV requiring recharge during the event must do so outside the pit and sprint track zone.

## **SIGNAGE**

Each EV must have signage for component identification, affixed in accordance with the Electric Vehicle Appendix – EV Technical Regulations, in addition to any other compulsory signage requirements.

Production EV's have extensive hazard signage already affixed, as per factory requirements.



**Electric Vehicle (EV)** External identification that the vehicle is an EV. Must be fitted in the vicinity of the competition number on both sides of the vehicle.  
Each side of the triangle must be 150mm.

### **EV RESPONSE (EVR) PLAN - The 3 Step Electric Vehicle Response “PROCESS”**

In general, the process for attending an incident involving an EV can be summarised in 3 steps.

#### **1 – APPROACH**

Approach the cockpit location from the side.

Ensure that all attending are wearing the required PPE and have the necessary equipment, e.g. rescue hook.

#### **2 – CHECK STATUS**

Series Production EV

Check the Status Indicator in accordance with the ERG for that EV.

If **SAFE** Status is displayed, proceed.

If **UNSAFE** Status is displayed:

(i) immediately advise others in the vicinity that the status is UNSAFE.

(ii) check if the Ready to Move Indicators is illuminated, and if so, follow the procedure in the relevant ERG. If this requires opening a door or similar (e.g. to disconnect an HV system plug, cut a cable), proceed with caution.

Status Notification

The status of the EV must be communicated to any person who may be involved at a later time, e.g. the Clerk of the Course, Recovery/Tow officials, Fire officials, Scrutineers, team personnel.

#### **Status not confirmed**

If the status of the EV cannot be confirmed SAFE, the HV systems of the EV must be treated as live.

#### **3 – RECOVERY**

Provided the appropriate PPE is worn and if the status is confirmed SAFE, EV recovery may proceed accordingly. Collection of any damaged part must be carried out with care.

### Motorsport Australia Capacity Multipliers:

Forced induction (Petrol) = Engine capacity (cc) x 1.7

Forced induction (Diesel) = Engine capacity (cc) x 1.5

Rotary engines = Engine capacity (cc) x 1.8

If forced induction rotary then (cc x 1.8) x 1.7

## 9.0 RUNNING OF THE EVENT

### 9.1 Competition Outline – single vehicle release

Vehicles will be released from the start line one at a time.

Vehicles will be brought to the line under the control of the start official. The driver must then wait for the Red light to change to Green before proceeding.

Once a vehicle has crossed the finish line and slowed to a safe speed, the next vehicle will commence its run when deemed safe to do so. There will be no passing on the track.

In the event of an incident, red flags will be displayed and all vehicles are to stop as quickly and safely as possible and await further instructions from officials.

### 9.2 The program will include provision for 4 runs. The first run will be a timed practice. The number of runs may be reduced if the competition is interrupted.

#### 9.2.1 2+4 Top Ten Shootout.

The ten (10) fastest times each day across motorcycles and cars will be entitled to compete in a single run Top Ten shoot out, at the discretion of the Secretary of the Event.

### 9.3 Competition Order

Vehicles will run in class order. Any competitor not ready to start when called to the start line may forfeit that run.

### 9.4 Start/Finish Lines

The START and FINISH lines will be defined by pylons, signs and banners.

### 9.5 The FINISH line will also be defined by large signs at either side of the road.

“Brake Now” markers will be located past the finish line on each side of the track.

The end of the Braking Area and the left hand turn into the holding area will be defined via significant visual devices at either side of the road. Large signage will be located at this point noting the turn off into the Holding Area.

The drivers briefing is held at the finish line each morning before competition, to highlight the beginning of the braking area.

### 9.6 Timing

All competition vehicles will be timed by light beam.

Vehicles are timed individually.

## 9.7 Vehicle Movement

During competition or practice, vehicles will NOT have entry to the pit area or tender car park areas. Upon completion of a run, cars will proceed from the Braking Area to the Holding Area.

When a suitable number of competitors have gathered in the Holding Area, they will return to the pit area slowly. Entry to the Pit area will be permitted during the return periods.

**NOTE:** Drivers MUST travel through the Holding Area and associated roadways at no more than walking pace.

## 9.8 Unsafe Conduct

Competing vehicles deemed by the Clerk of Course to be driven in an unsafe manner, having regard to the prevailing conditions, will be liable to be disqualified from further competition.

## 9.9 Tyre Warming

This is a smoke-free environment. Under no circumstances is tyre warming permitted at any time before or during competition.

Drivers will be excluded from competition if they produce excessive tyre-smoke.

## 9.10 Damage / Accidents – vehicle damage and property damage

Any vehicle towed, trailered, or removed from the course during practice or competition due to damage must be re-examined by the scrutineers before returning to competition.

**Vehicles involved in accidents resulting in property damage will be required to pay for any property damage.**

## 9.11 Tender Vehicles & Trailers

**ANY NON-COMPETITION VEHICLES REMAINING IN THE PITS AFTER DRIVERS BRIEFING WILL BE CHARGED A FULL-PRICE SPRINT ENTRY.**

As in previous years there must be no tender vehicles or trailers in the Pit area.

Tender vehicles and trailers may unload and load on the sprint track, parking the competitive vehicle into the pre-assigned Pit area before the tender vehicle and trailer are removed to the designated Hearne Parade parking areas.

See map (provided in Competitor Information pack).

## 9.12 Access Point

The Yarra Street and Brougham Street intersection is the only point of access to the event course and will be closed at 9:00am (8.30am Sunday), competitors are asked to arrive as early as possible, preferably at 7am, in order to avoid any delay in the commencement of competition due to incompleteness of scrutiny.

## 9.13 Start

The sprint will commence at 10:00am Saturday and 9:00am Sunday.

#### 9.14 Competition Schedule

There will be a competition schedule available at Document Check-In, but this may be affected by events on the day.

It is the competitor's responsibility to be ready when given the 5 Minute call to their pit group. Any competitor not ready to start when called to the start line may forfeit that run.

#### 9.15 No staking in the ground

Weather permitting, marquees and shade structures are welcome on the grass behind the pit spaces. Weights must be used to secure them. There must be no pegs or stakes in the ground.

If requested by a race official to remove the structures for any reason, please do so promptly.

#### 9.16 No dogs or barbeques

There are no dogs or barbeques permitted in the pit area. This excludes service animals.

### 10 ENTRY DETAILS

#### 10.0 Entries

Competitor numbers will be limited to a maximum permitted by the Organiser for the category concerned. Should an excess of entries be received in any one group and/or combined group as decided by the Organiser, preference will be given in order of receipt of entries.

Should insufficient entries be received in a particular category or class, the Organiser reserves the right to combine classes, restructure the program and/or reject entries.

Maximum numbers of entries for this event will be 100 vehicles per day, or at the discretion of the Organiser.

\* This fee includes one competition entry for one driver and two pit crew, a single pit-bay and two race number stickers.

\* Single-Event Licences are NOT available for this event. Competitors must hold an annual Motorsport Australia "Speed" Licence.

### 10.4 Log Book

If a Log Book has been issued for a particular vehicle, the Log Book must be presented. Associated details must be recorded under the headings provided on the Entry Form.

### 10.5 Drivers

A vehicle entry is for four competitive passes, which may be shared by multiple drivers. Each driver will be assigned a separate race number.

Vehicles may only be driven by the driver/s nominated on the Entry Form.

The driver/s must present at Document Check-in on the morning of competition, or they will not be able to compete.

### 10.6 Entry Variation

Variations are permissible (vehicle swap and / or driver swap).

A vehicle swap is not eligible for a partial refund.

No On-The-day swaps permitted. Any variation to the originally entered vehicle must be organised prior to the event by contacting the Secretary of the Event.

## 11.0 DRUGS AND ALCOHOL

### 11.1 INTEGRITY, ALCOHOL, DRUGS AND OTHER SUBSTANCES

Smoking (which includes e-cigarettes and "vaping") and any naked flame is prohibited within 3 metres of any refuelling/defueling operation.

Motorsport Australia's National Integrity Framework and any associated policy (including the Australian Anti-Doping Policy, Motorsport Australia's Illicit Drugs in Sport (Safety Testing) Policy, the Motorsport Australia Alcohol Policy), apply to any activity authorised by Motorsport Australia as published at [www.motorsport.org.au](http://www.motorsport.org.au).

Any Participant including the holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol, any drug or other banned substance. In addition to any penalty imposed by Motorsport Australia, a further penalty/s may be applied by Sport Integrity Australia.

Consumption of alcohol in any Reserved Area is prohibited until all Competition is concluded each day.



## 12.0 SERVICE AND RE-FUELLING

### 12.1 Refuelling

In consultation with the Fire Rescue Victoria, Victoria Police & Worksafe Victoria, you will not be able to refuel at the event.

If any fuel is bought onto the site precinct, you will need to declare it & it will be taken away offsite for the duration of the event. At the conclusion of the sprints each day, the fuel will be returned to site & competitors will be able to pick it up. Fuel must comply with Schedule G of the Motorsport Australia Manual.

***AFTER DRIVERS BRIEFING ANYONE FOUND WITH FUEL IN CONTAINERS IN THE PITS WILL BE IMMEDIATELY DENIED THE RIGHT TO PARTICPATE IN THEEVENT.***

### 12.2 Speed Limit

The speed of cars in the holding bay Pits must not exceed 10km/h. For vehicles without a speedometer, a slow walking pace is the guide. Offenders will be referred to the Stewards.

## 13.0 DOCUMENTATION & SCRUTINY

### 13.1 Document Check In will be carried out at the Competitor Office, located in the Sprint Pits behind the Start Line from 7:00am.

Ensure you bring

- your Competitor/Driver Disclaimer,
- Motorsport Club membership card,
- Drivers Licence,
- Motorsport Australia Competition Licence,
- Log Book (if issued) and
- proof of vehicle ownership (registration or insurance documentation).

At Document Check-in, drivers will be issued a wrist band which must be worn at all times. Any driver not displaying this wristband will not be permitted to compete. Race Stickers will also beprovided at Document Check-in.

### 13.2 Outstanding Entry Fees

A driver will not pass documentation until all fees are paid to the satisfaction of the Organiser.

### 13.3 Scrutineering

Vehicle scrutineering will commence at 7:00am on the day of competition. Vehicles will be scrutineered in their pit location, as directed by the officials of the event. Refer to Article 7 of the Supplementary Regulations for the requirements.

To be scrutineered, the vehicle must be attended, unlocked and with access to passenger compartment, boot and engine bay.

If the vehicle is not scrutineered, it will not be permitted to compete.

### 13.4 Pre-Start Scrutineering

Vehicles must be presented in a ready to start condition with all compulsory equipment on board, including safety helmets, fire resistant gloves (for open-cabin vehicles) and all other apparel directly after documentation.

### 13.5 Failure to Pass Pre Start Scrutineering

Should a vehicle fail to pass pre-start scrutiny when presented it must be re-presented at a time decided by the Chief Scrutineer.

### 13.6 Inappropriate Appearance or Condition

If a vehicle is deemed by the organisers to be of an appearance or condition inappropriate to the standards of the event, the competitor will be denied permission to start in the event unless the deficiencies are rectified

### 13.7 Recognition Paper

Participants may be required to produce the appropriate vehicle recognition documents (eg. homologation papers, workshop manuals, sales brochures, etc.) to be checked against the vehicle should this be necessary at pre-start and post-event scrutineering. Failure to produce these documents may lead to a **penalty of disqualification** being applied by the Stewards.

### 13.8 Driver Briefing

A **compulsory driver briefing** will be conducted at 9:30am (Saturday) and 8:30am (Sunday) **at the finish line**.

**Non-attendance at the drivers briefing will result in being unable to compete.**

### 14.2 AWARDS

Trophies will be presented to the winner of each class and the winner of the Top 10 shootout.

Trophies will be decided on the fastest timed run.

Clubs attending on the day are free to present their own awards as part of the official award presentation.

Trophies will be available for collection from the Competitors Office at the conclusion of the competition on both days.

Trophies **MUST** be collected on the day. The Organiser will not be responsible for the delivery of trophies after the event.
